

STIPULATION OF SETTLEMENT AND DISCONTINUANCE

Claim No. 87328 Sise, P. J.

Defendant.

WHEREAS, the parties hereto have agreed to settle this claim pursuant to the provisions of Section 20-a of the Court of Claims Act, and the claim alleges that claimant suffered loss of liberty, including physical injuries and conscious pain and suffering; and

WHEREAS, defendant the STATE OF NEW YORK, has approved settlement of the claim under the terms and conditions set forth below, and NOW, THEREFORE, IT IS STIPULATED AND AGREED, by and between the undersigned, the attorneys of record for all of the parties in the above-entitled action, that whereas all the parties thereto are adults or corporations, and no party hereto is an infant or incompetent person for whom a committee has been appointed, and no person not a party has an interest in the subject matter, the above-entitled action be, and the same hereby is, settled, and upon payment of the sum of One Million Two Hundred and Fifty Thousand Dollars (\$1,250,000), discontinued with prejudice pursuant to Section 20-a of the Court of Claims Act.

We, the attorneys for the claimant, do hereby release and waive our lien for services upon the above-named claimant's cause of action, claim, verdict, report, judgment, determination, or settlement in favor of said claimant which we have thereon under and by virtue of Section 475 of the Judiciary Law or otherwise.

We, the attorneys for the claimant, do further represent that there is no other attorney having a lien for services rendered to claimant related to the subject matter of this cause of action, Claim No. 87328, except for the attorneys specifically enumerated herein, pursuant to the provisions of Section 475 of the Judiciary Law or otherwise.

We, the attorneys for the claimant, represent that attorney Susan Barrie, Esq. has a lien for \$46,423.50, and attorney Bernard H. Segal, Esq. has a lien for \$12,775.00, which will be paid by BOND, SCHOENECK & KING, PLLC, out of the settlement proceeds of this claim.

Claimant represents and warrants that he is not a Medicare recipient, has never been on Medicare or Social Security Disability, that no conditional payments have been made by Medicare and that he does not expect to be a Medicare recipient within the next 30 months.

Payment shall be made by check made payable to the order of AMINE BABA-ALI and BOND, SCHOENECK & KING, PLLC, as attorneys, in the amount of One Million and Two Hundred and Fifty Thousand Dollars (\$1,250,000) and mailed to Nicholas J. D'Ambrosio, Jr., Esq., BOND, SCHOENECK & KING, PLLC, 111 Washington Avenue, Albany, New York, 12210-2211. This Stipulation may be signed in counterparts and an executed facsimile copy of this Stipulation shall be deemed to have the same force and effect as a signed original.

Payment of the amount referenced above will be made in accordance with the provisions of CPLR 5003-a(c) after the approval of this Stipulation of Settlement and Discontinuance by the Court and receipt by defendant's counsel of a copy of the So-Ordered Stipulation, Release to the defendant State of New York and a certified copy of the Claim.
